Any person who makes or causes to be made any knowingly false or fraudulent material statement or material representation for §5401.7

the purpose of obtaining or denying workers' compensation benefits or payments is guilty of a felony.

COLORADO All insurance applications, policy and claim forms:

It is unlawful to knowingly provide false, incomplete, or misleading facts or information to an insurance company for the purpose §10-1-128 of defrauding or attempting to defraud the company. Penalties may include imprisonment, fines, denial of insurance, and civil

damages. Any insurance company or agent of an insurance company who knowingly provides false, incomplete, or misleading facts or information to a policyholder or claimant for the purpose of defrauding or attempting to defraud the policy-holder or claimant with regard to a settlement or award payable from insurance proceeds shall be reported to the Colorado Division of

Insurance within the Department of Regulatory Agencies.

DELAWARE All insurance claim forms:

Any person who knowingly, and with intent to injure, defraud or deceive any insurer, files a statement of claim containing any false, 11§913

incomplete or misleading information is guilty of a felony.

Any person who, knowingly and with intent to injure, defraud, or deceive any employer or employee, insurance company, or selfinsured program, files a statement of claim containing any false or misleading information commits insurance fraud, punishable as

provided in §817.234.

HAWAII All auto insurance applications and claim forms:

For your protection, Hawaii law requires you to be informed that presenting a fraudulent claim for payment of a loss or benefit is §431:10C-307.7

a crime punishable by fines or imprisonment, or both.

IDAHO All insurance claim forms;

Any person who knowingly, and with intent to defraud or deceive any insurance company, files a statement containing any false, §41-1331

incomplete, or misleading information is guilty of a felony.

A person who knowingly and with intent to defraud an insurer files a statement of claim containing any false, incomplete, or §27-2-16-3

misleading information commits a felony.

All insurance claim forms: **KENTUCKY** §304.47-030

Any person who knowingly and with intent to defraud any insurance company or other person files a statement of claim containing materially false information or conceals, for the purpose of misleading, information concerning any fact material thereto commits

a fraudulent insurance act, which is a crime.

All insurance application forms:

Any person who knowingly and with intent to defraud any insurance company or other person files an application for insurance containing any materially false information or conceals, for the purpose of misleading, information concerning any fact material

thereto commits a fraudulent insurance act, which is a crime.

LOUISIANA All insurance applications and claim forms: §40:1424

Any person who knowingly presents a false or fraudulent claim for payment of a loss or benefit or knowingly presents false

information in an application for insurance is guilty of a crime and may be subject to fines and confinement in prison.

MAINE

All insurance applications and claim forms:

§2186(3)(A)

It is a crime to knowingly provide false, incomplete or misleading information to an insurance company for the purpose of defrauding the company. Penalties may include imprisonment, fines or a denial of insurance benefits.

MINNESOTA

All insurance claim forms:

§60a.955

A person who files a claim with intent to defraud or helps commit a fraud against an insurer is guilty of a crime.

§176.178

All workers' compensation claim forms:

Any person who, with intent to defraud, receives workers' compensation benefits to which the person is not entitled by knowingly misrepresenting, misstating, or failing to disclose any material fact is guilty of theft and shall be sentenced pursuant to section

609.52, subdivision 3.

NEW HAMPSHIRE §402:82

All insurance claim forms:

Any person who, with a purpose to injure, defraud or deceive any insurance company, files a statement of claim containing any false, incomplete or misleading information is subject to prosecution and punishment for insurance fraud, as provided in RSA638:20.

NEW JERSEY

All insurance claim forms:

§17:33A-6

Any person who knowingly files a statement of claim containing any false or misleading information is subject to criminal and

civil penalties.

All insurance application forms:

Any person who includes any false or misleading information on an application for an insurance policy is subject to criminal

and civil penalties.

NEW MEXICO §59A-16C-8

All insurance applications and claim forms:

ANY PERSON WHO KNOWINGLY PRESENTS A FALSE OR FRAUDULENT CLAIM FOR PAYMENT OF A LOSS OR BENEFIT OR KNOWINGLY PRESENTS FALSE INFORMATION IN AN APPLICATION FOR INSURANCE IS GUILTY OF A CRIME AND

MAY BE SUBJECT TO CIVIL FINES AND CRIMINAL PENALTIES.

NEWYORK §403(d)

All insurance applications and claim forms except auto:

Any person who knowingly and with intent to defraud any insurance company or other person files an application for insurance or statement of claim containing any materially false information, or conceals for the purpose of misleading, information concerning any fact material thereto, commits a fraudulent insurance act, which is a crime, and shall also be subject to a civil penalty not to

exceed five thousand dollars and the stated value of the claim for each such violation.

§403(e) All auto insurance applications and claim forms:

> Any person who knowingly makes or knowingly assists, abets, solicits or conspires with another to make a false report of the theft, destruction, damage or conversion of any motor vehicle to a law enforcement agency, the department of motor vehicles or an insurance company, commits a fraudulent insurance act, which is a crime, and shall also be subject to a civil penalty not to exceed

five thousand dollars and the value of the subject motor vehicle or stated claim of each violation.

OHIO §3999.21 All insurance applications and claim forms:

Any person who, with intent to defraud or knowing that he is facilitating a fraud against an insurer, submits an application or files

a claim containing a false or deceptive statement is guilty of insurance fraud.

OKLAHOMA §3613.1

All insurance applications and claim forms:

WARNING: Any person who knowingly, and with intent to injure, defraud or deceive any insurer, makes any claim for the proceeds

of an insurance policy containing any false, incomplete or misleading information is guilty of a felony.

PENNSYLVANIA

§18-4117

All insurance applications and claim forms:

Any person who knowingly and with intent to defraud any insurance company or other person files an application for insurance or statement of claim containing any materially false information or conceals for the purpose of misleading, information concerning any fact material thereto commits a fraudulent insurance act, which is a crime and subjects such person

to criminal and civil penalties.

All auto applications, renewals and claim forms: §75-1822

Any person who knowingly and with intent to injure or defraud any insurer files an application or claim containing any false, incomplete or misleading information shall, upon conviction, be subject to imprisonment for up to seven years and payment of a

fine of up to \$15,000.

TENNESSEE: §56-53-111

All insurance applications and claim forms:

It is a crime to knowingly provide false, incomplete or misleading information to an insurance company for the purpose of

defrauding the company. Penalties include imprisonment, fines and denial of insurance benefits.

All workers' compensation applications and claim forms: §56-47-112

It is a crime to knowingly provide false, incomplete or misleading information to any party to a workers' compensation transaction

for the purpose of committing fraud. Penalties include imprisonment, fines and denial of insurance benefits.

TEXAS:

All insurance claim forms:

§704.002(a) Any person who knowingly presents a false or fraudulent claim for the payment of a loss is guilty of a crime and may be subject

to fines and confinement in state prison.

UTAH: §34A-2-110 All workers' compensation applications and claim forms:

Any person who knowingly presents false or fraudulent underwriting information, files or causes to be filed a false or fraudulent claim for disability compensation or medical benefits, or submits a false or fraudulent report or billing for health care fees or other

professional services is guilty of a crime and may be subject to fines and confinement in state prison.

VIRGINIA: All insurance applications and claim forms:

§52-40

It is a crime to knowingly provide false, incomplete or misleading information to an insurance company for the purpose of

defrauding the company. Penalties include imprisonment, fines and denial of insurance benefits.
